Forbes and Lomax Push Buttons are momentary switches, also known as low voltage dry contact closure switches or push-to-make switches and can be used to control dimming devices and lighting control or home automation systems by other manufacturers. If interfacing the Push Buttons with systems made by others, contact the manufacturer of the system to check the suitability.

### WARNINGS AND CAUTIONS

- To be installed and/or used in accordance with appropriate electrical codes and regulations.
- For professional use only – should only be installed by a qualified electrician.
- Use copper conductors.
- Should be wired in the field as a part of a Class 2 circuit only.
- Connect to 22-12AWG copper or copper clad wire.
- When field-installed conductors are routed with conductors of other circuits, the conductors shall be insulated for the maximum voltage of either circuit.
- Bonding between conduit connections is not automatic and must be provided as part of the installation.
- Recommended terminal screw torque is 4.0 lb in.

### IMPORTANT NOTICE FOR INSTALLER:

To achieve proper aesthetic installation, the wall surface surrounding the wall box opening must be flat and free of irregularities. The wall box must be recessed below the wall surface by 4mm to allow the wallplate to sit completely flush when fitted. Please also refer to the 'Instructions for Electricians & Decorators' leaflet.
